**GOVERNING BODY NOMINATIONS - MOSLEM CEMETERY BOARD - SPECIAL GENERAL MEETING –
21 JUNE 2026**

1. Nominations for election to the Governing Body of the Moslem Cemetery Board to be convened at the Special General Meeting (“SGM”) scheduled for Sunday, 21 June 2026 shall only be accepted on the prescribed Nomination Forms issued by the Moslem Cemetery Board.
2. Prescribed Nomination Forms may be obtained from Mowbray Cemetery, situated at 10 Browning Road, Observatory, Cape Town, or may be downloaded electronically from the official website at www.MowbrayCemetery.org
3. Participation in the nomination and election process shall be confined to persons duly registered as members pursuant to the court-directed membership reopening and regularisation process initiated on 15 April 2026.
4. No person shall be entitled to nominate, second a nomination, stand for election, vote or otherwise participate in the SGM unless his or her name appears on the membership register compiled for purposes of the SGM.
5. Every nomination shall:
 - 5.1 be completed in full on the prescribed Nomination Form;
 - 5.2 clearly indicate the position for which the nominee is nominated with a “X”;
 - 5.3 be signed by not fewer than three (3) duly registered members entitled to participate in the SGM;
 - 5.4 bear the signature of the nominee signifying his or her willingness to accept nomination and, if elected, to serve accordingly; and
 - 5.5 be submitted together with such supporting documentation as may be reasonably required by the Board or Electoral Committee.
6. Nominations for Election to the Governing Body may be submitted for the following positions:
 - 6.1 Chairperson;
 - 6.2 Secretary;
 - 6.3 Treasurer; and
 - 6.4 Board Member (additional).
7. Applications for Membership Registration and Nomination for Election to the Governing Body must be submitted by no later than Friday 12 June 2026 at 17h00.
8. Completed Nomination Forms and supporting documentation must be delivered to Mowbray Cemetery, 10 Browning Road, Observatory, Cape Town, or transmitted electronically to Membership@MowbrayCemetery.org

The Moslem Cemetery Board reserves the right to reject any nomination which does not comply with the requirements contained herein, the 1948 Constitution, Judgment of the High Court of South Africa under Case No. 2025-238197, or any electoral procedures lawfully adopted for purposes of the SGM.
